TOUR & TRAVEL

Alaska Tour & Travel (AT &T) offers a Medical Cancellation Waiver (MCW) program which will waive cancellation penalties when a reservation is cancelled due to sickness, injury or death of a traveling companion or family member. The MCW is not a substitute for travel insurance and does not cover items such as medical expenses, emergency transportation, travel delays and lost luggage. **The MCW is automatically included in your reservation, but can be declined anytime up to 45 days prior to your first day of travel by returning the attached card.**

The cost of the program is 3% of tour cost and is included in the package price shown on your reservation. The MCW does not apply to or cover seven-day Gulf of Alaska cruises or escorted tours, and advance notice of cancellations must be given to AT&T

#### Additional MCW Details

Cancellation penalties will be waived for services purchased through Alaska Tour & Travel (AT&T) when the cancellation is a direct result of sickness, injury or death of a traveling companion or family member. This does not cover sickness, injury or death caused by a natural disaster including, but not limited to, fires, floods, or earthquakes. Traveling companions include all passengers in your party booked on the same itinerary through AT&T and covered by the MCW. Family members include traveler's spouse, parent, child, sibling, grandparent, aunt, uncle, niece, nephew or legal guardian. Sickness or injury requires a doctor's care and a written statement from a doctor is necessary. In case of a death, a copy of a death certificate will be required. In order for cancellation penalties to be waived, you must give notice to AT&T 24 hours prior to the cancelled service. You can reach Alaska Tour & Travel at (800) 208-0200 or (907) 245-0200. The MCW does not apply to or cover seven-day Gulf of Alaska cruises or escorted tours. You may decline the MCW anytime up to 45 days prior to your first day of travel without penalty by providing written notification either by email or by mail. AT&T will not be responsible for cards lost or delayed in the mail. You can verify receipt by calling AT&T at (800) 208-0200. The MCW is not travel insurance nor is it meant to be a substitute for travel insurance. We highly encourage all clients to purchase travel insurance as an alternative to the MCW, and information on travel insurance has been included with your reservation confirmation.
